SITUATION				
<b>Current Situation:</b>	<p>CAL FIRE and the USDA Forest Service, Los Padres National Forest remains in unified command. The fire continues backing in the Coast Ridge area above Big Sur. The fire continues backing into the Carmel and Ventana drainages.</p> <p>Due to anticipated firing operations in the Big Sur area tomorrow, Hwy 1 will be closed at 2:00 p.m. on August 14, 2016 for up to 24 hours from Point Sur Lighthouse to North Coast Ridge Rd.</p> <p>Pre-planning continues to mitigate potential future threat. Fire continues to burn in steep, rugged and inaccessible terrain. A State of Emergency has been declared by the Governor.</p> <p>Cause of the Soberanes Fire was an illegal campfire. Anyone with information is asked to call the CAL FIRE Tip Line at: (800) 468-4408.</p> <p>The Damage Inspection Team continues working in collaboration with Monterey County Office of Emergency Services on assessment of damaged structures and infrastructure. A total of 57 residences and 11 outbuildings have been destroyed. Three residences and two outbuildings have been damaged. An Air Resource Advisor is assigned to the incident and is working with local and state air quality officials to analyze the impact the smoke is having on the public.</p> <p>US FOREST SERVICE TRAIL AND ROAD CLOSURES: A forest closure order has been implemented to close the trails and roads within the Los Padres National Forest, Monterey Ranger District pursuant to USC 551 and 36 CFR 261.50(a). The order prohibits going into or being upon National Forest System lands within the Soberanes Fire area. <a href="http://www.fs.usda.gov/lpnf">www.fs.usda.gov/lpnf</a></p> <p>CALIFORNIA STATE PARK CLOSURES: All California State Parks from Garrapata State Park through Julia Pfeiffer Burns State Park are closed until further notice; which includes Point Sur State Historic Park (Lighthouse), Andrew Molera State Park, Pfeiffer Big Sur State Park Campground and Day Use. 380 residents have been evacuated along with several road closures listed in the Evacuations section below.</p>

<b>Evacuations:</b>	<p><b>EVACUATION ORDERS:</b> Areas that are under evacuation orders include Coast Rd, from the 2-mile marker south to Coast Ridge Road on the East side of Hwy 1 to include all areas accessed by these roads.</p> <p><b>EVACUATION WARNINGS:</b> Areas are under evacuation warnings, West of Hwy 1 at Coast road at the intersection of Andrew Molera State Park to Graves Canyon. Cachagua Road at Nason Road to Trampa Canyon Rd, Cachagua Road from Carmel Valley Road to Tassajara Rd, Tassajara Road from Carmel Valley Road to the Tassajara Hot Springs Zen Center. This area includes all roads that lead from the above described roads.</p> <p>Residents should <b>prepare</b> to leave the areas listed above and be sure to take any medications, pets, family valuables, etc. with you. Close all windows and leave all doors closed.</p> <p>All residents are asked to be <b>READY</b>: Create and maintain defensible space and harden your home against flying embers. Get <b>SET</b>: Prepare your family and home ahead of time for the possibility of having to evacuate. Be <b>Ready to GO!</b> Take the evacuation steps necessary to give your family and home the best chance of surviving a wildfire.</p> <p>For more information on “Ready, Set, Go”, go to <a href="http://www.readyforwildfire.org">www.readyforwildfire.org</a>.</p>
<b>Road Closures:</b>	<p>Coast Rd, Apple Pie Ridge Road, Coast Ridge Road. Hwy 1 will be closed at 2:00 p.m. on August 14, 2016 for up to 24 hours from Point Sur Lighthouse to North Coast Ridge Rd.</p>
